**ORDER FOR ATTENDANCE OF WITNESS
FROM WITHOUT THE STATE IN CRIMINAL CASES**

It appearing from the Petition of Brent Davis, the duly elected, qualified and acting Prosecuting Attorney within and for the Second Judicial Circuit of the State of Arkansas, of which Craighead County is a part, that one Holly George, presently residing at 5639 North Street in Bartlett, Tennessee, is a material and necessary witness for the State of Arkansas upon the trial of the above-named defendants, Charles Jason Baldwin and Damien Wayne Echols, in the Circuit Court of Craighead County, Arkansas, for the felony crime of Capital Murder (three counts), and it appearing that it will not be an undue hardship on the witness to be required to attend and testify in said Circuit Court on February 25, February 28 and March 1, 1994, nor will the witness be required to travel more than one thousand (1,000) miles to reach the place of trial by ordinary traveled routes, and it further appearing that the State of Arkansas and County of Craighead will grant both civil and criminal immunity to the said witness while en route to the place of trial and while in Craighead County, Arkansas, testifying at said trial, and that the State of Arkansas has tendered the sum of Nineteen and 20/100ths

Dollars (\$19.20) for payment to the said Holly George representing mileage at the rate of twelve cents (12 cents) for each mile to be traveled (160 miles round-trip), and the sum of Seventy-five Dollars (\$75.00) representing Twenty-five Dollars (\$25.00) for each day that she is required to travel and attend as a witness (3 days).

IT IS, THEREFORE, ORDERED that Holly George, presently residing at 5639 North Street in Bartlett, Tennessee, does attend as a witness before the Craighead County Circuit Court at the Federal Courthouse located in Jonesboro, Arkansas, on February 25, February 28 and March 1, 1994, as commanded by the Subpoena or Summons attached hereto.

IT IS FURTHER ORDERED that there shall be paid to the said Holly George the sum of Nineteen and 20/100ths Dollars (\$19.20) as compensation at twelve cents (12 cents) per mile for each mile to be traveled by ordinary traveled route to and from the Court where the prosecution is pending (160 miles round trip), and that she be further paid the sum of Seventy-five Dollars (\$75.00) representing Twenty-five Dollars (\$25.00) as compensation for each day necessarily traveled in going to and returning from the place of trial and as payment for each day required to attend as a witness (3 days), for a total of Ninety-four and 20/100ths Dollars (\$94.20).

IT IS SO ORDERED this 15th day of February, 1994.
