1	Q] Okay. Can you do that?
2	A] I'd be glad to.
3	Q] Okay. And just one other thing. In terms of the places
4	where you have worked and performed autopsies, do you have, is
5	there any set number of tissue slides that you take in
6	connection with a case?
7	A] It depends on the case; it totally depends on the case. If
8	it's a sudden infant death syndrome, there's a certain set and
9	if there's a brain injury, there's another set and if it's a
10	traffic accident, then it's another number. So I don't have a
11	particular number.
12	Q] Okay.
13	MR. HOLT: That's all. Thank you, Doctor.
14	MR. PHILLIPSBORN: I have no further questions.
15	MR. BURT: No further questions.
16	THE COURT: All right, you're free to go. Thank
17	you very much.
18	THE WITNESS: Thank you.
19	THE COURT: Call your next witness.

(Witness nods head affirmatively.) 13 Who was Jason's biological dad? Q] 14 Αl Uh, Charles Larry Baldwin. 15 Q]At some point, did y'all divorce? 16 AUh, yes. 17 Q1And did you subsequently remarry? Okay. 18 AYes. 19 Q] And who did you remarry? Terry Ray Grinell. 20 A21 Uh, generally, do you remember how old Jason was around the 22 time y'all got divorced, or let me put it this way: about how 23 old Jason was when you married Terry Ray Grinell?

- 2 | Q Did you and, uh, just tell us quickly about your children.
- 3 | You have Jason; is he the oldest?
- 4 | A | Yes.
- 5 | Q | Who is the next child that you've got?
- 6 [A] Uh, okay now, I don't know what this has got to do with
- 7 | Jason's uh, uh, Jason, uh, coming home.
- 8 ||Q| Tricky lawyer questions.
- 9 | A] Oh. Okay.
- 10 | Q All right. You've got three children?
- 11 | A] Right.
- 12 [Q] Jason; who's next in line?
- 13 || A] Uh, Larry Matthew.
- 15 | A] Right.
- 16 ||Q] And you have another son?
- 17 | Al Yes.
- 18 Q And what's his name?
- 19 | A] Terry Grinell.
- 20 | Q And I assume Terry Ray Grinell is his biological dad?
- 21 [A] Right. And he passed away.
- 22 ||Q| Back in 1993 where were y'all living?
- 23 [A] Uh, Lakeshore Trailer Park.
- 24 ||Q| And that's in Lakeshore Park outside of West Memphis?
- 25 | A] It's between West Memphis and Marion, kinda.

- Okay. Who all was living in your house, Gail, back in
- 2 | 1993?
- 3 | A] Uh...
- 4 ||Q] ...you, obviously?
- 5 [A] Right. Uh-huh. I had been head of the household there for
- 6 | quite a few years. Terry's dad hadn't lived there for a long

- 10 A And he wouldn't go and we had been arguing about that for

- 12  $\mathbb{Q}$  But he was there on May 5<sup>th</sup> and May 6<sup>th</sup>?
- 13 | A] Yeah.
- 14 Q Jason was living in the home at the time?
- 15 | A] Right.
- 16 | Q | Matthew, and also little Terry; right?
- 17 | A] Correct.
- 18 | Q Okay. How old was Jason back then?
- 19 | A | He was sixteen.
- 20 ||Q] Where was he going to school?
- 21 [A] He was going to school at Marion.
- 22 ||Q] Marion High School?
- 23 | A | Marion High School.
- 24 | Q Uh, how did he get to and from school in those days?
- 25 A He rode the bus.

- Q Rode the school bus?
- 2 | A] Yes.

- 3 | Q Okay. Where was Matt - how old was Matthew?
- 4 | A] Matthew is two years younger.
- 5 | Q | So he would have been fourteenish?
- 6 | A] Yeah.
- 7 | Q | Where was he going to school at the time?
- 8 | A] He was going to school at the same place, at the same
- 9 school and they rode the same bus.
- 10 Q So they were on the same bus?
- 11 | A | Yeah.
- 12 Q Okay. And how old was Terry back then?
- 13 [A] Terry?
- 14 ||Q] Little Terry?
- 15 [A] Uh, he was between eight or nine.

- 25 | that he liked to go fishing, uh, he had a TV in his room, he had

- weights in his room, he had, uh, and so, you know, he liked playing the Nintendo and playing, uh, on the weekends fishing, we had TV, we had, uh, uh, at that time they didn't have a whole lot of technology as they do today. We had a DVD player - not a DVD player, but...
- ||Q| ...VCR?

- 7 | A] VCR and all that kind of stuff, you know.
- 8 Q And I've seen the pictures from back then. He was sort of 9 a slight kid, kind of small built?
- 10 A] Yeah. He was, he was real short. At the time he was larrested, Jason was barely my height.
- Q Did you, Gail, see, was Jason a violent type of kid, was he getting in fights, was he a big discipline problem for you?
- 14 | A] No, he wasn't.
- 15 | Q | Was he known as a kid that would like pick on little kids?
- 16 | A] No.
- Q] Did you see, Gail, anything that caused you concern back then about Jason being involved in things like witchcraft and Satanism, the occult, anything like that?
- A] No, there wasn't. Somebody was trying to spread those rumors around and he did not. There, there was no such thing out there.
- 23 Q All right. Back, uh, Lakeshore is quite a distance from 24 West Memphis, isn't it?
- 25 | Al Yeah.

- Q] Did Jason have a car or access to a car back in those days?
- 2 A No. I was gonna try to get a car fixed, try to get him a
- 3 | car at the time that he got arrested, I was working on getting
- 4 | him a car.
- 5 Q I guess he just - he was sixteen or had just turned
- 6 sixteen at the time, so he was eligible to drive a car, but he
- 7 | wasn't driving a car back then?
- 8 A Right.
- 9 | Q Gail, a little bit more about you. You were working at the
- 10 | time; is that right?
- 11 | A | Yeah.
- 12 | Q] Where were you working?
- 13 | A] I was working for Customized Transportation Incorporated.
- 14 || Q| Where was that?
- 15 [A] It was in Memphis.
- 16 | Q In Memphis?
- 17 | A ] Uh-huh.
- 18 |Q] How long did you work there?
- 19 [A] I worked there for quite a few years.
- 20 [Q] What did you do for them?
- 21 [A] I had to do, I had to do a lot of data entry through
- 22 | typing, uh, answer phones.
- 23 | Q | So you were doing administrative stuff for them?
- 24 | Al Yeah.
- 25 ||Q| This is a trucking company, I guess?

- 1 A Yeah, I was, uh, I had to do all of that. I worked in the
- 2 office. I had to do, if something had to be sent out for parts
- 3 | for a car, I had to send, I had to make sure it got out.
- 4 | Q] Okay?
- 5 [A] I had to make sure, I had to make sure, I had to key punch
- 6 everything in so they could load the freight up on the trucks.
- 7 | I had to type letters, I, uh, you know, and but I had my own
- 8 phone, my own desk and, uh, I was able to call my sons, uh, my
- 9 | children whenever, and they knew my phone number, they could
- 10 | call. They knew they could call me at work at any time.
- 11 ||Q] And did they?
- 12 [A] Yes. And they hardly ever called me at work. They didn't
- 13 | have many emergencies at home, uh, but I would always call them.
- 14 | Q And, and they did not have a lot of emergencies at home.
- 15 | Was Jason the big brother and taking care of his two little
- 16 | brothers often times?
- 17 | A] Most of the time; yeah.
- 18 | Q And did he do a good job at that?
- 19 | A | Yes, he did.
- 20 | Q What hours were you working back then in 1993?
- 21 | A | Uh, okay, they would switch my hours around. Sometimes I
- 22 | worked three to eleven, sometimes two to ten. Sometimes I'd
- 23 | have to work thirty minutes over.
- 24 ||Q] 3:00 p.m. to 11:00 p.m.?
- 25 | A] Yeah. I didn't get a lunch, I didn't take a lunch break at

- 1 night.
- What time back then would you generally get home? 01
- It would take me about thirty minutes to get home. 3 A]
- And if I remember right, May 5<sup>th</sup> and 6<sup>th</sup> is in the week and 4 Q]
- you worked during the regular work week, you would have worked 5
- on a Tuesday, Wednesday, Thursday, is that right? 6
- Αl 7 Huh?
- Is that right? 8 A
- Excuse me? **A**]
- Uh, if I remember right, May 5<sup>th</sup> and 6<sup>th</sup>, I think, was in the 10
- middle of the week. Did you work during the regular week, 11
- Monday through Friday or was it a Tuesday, Wednesday or
- Thursday, you would have been working; correct? 13
- 14 Αl (Witness nods head affirmatively.)
- Is that a yes? 15 Q]
- (Witness nods head affirmatively.) 16 ΑÌ
- Now when you were at work, because you go to work in the Q]
- afternoon, well, when would the boys get home from school? 18
- 19 Αl They got home 'tween 3:30 and four.
- Q] So it was after you had already gone to work? 20
- 21 A] 'Tween 3:30 and four, I think is when they got home.
- 22 Q] They got home after you had already left for work?
- 23 A] Right.
- Okay. And you at the office, you mentioned something about 24 Q1
- this: you checked in by telephone with them?

- 1 A Yeah.
- 2 | Q | And was that something regular and customary that you did?
- 3 | A | Yeah.
- 4 | Q | What would you do? How often would you call?
- 5 [A] I would call. You see, one good thing about my job, I was

- 15 Q] Was that sort of Jason's role then to make sure the younger 16 boys got, in fact, ate dinner that night?
- 17 | Al Yeah.
- Q] Okay. So you would get home, you would check in on the boys, 11:30ish midnight, I guess. Typically, were they in bed?
- 20 | A | Huh?
- 21 | Q | Would they be in bed by the time you got home?
- 22 [A] Yeah, they were always.
- 23 | Q Okay?
- 24 | A] They were always in bed when I got home.
- 25 | Q | So after you checked on the boys, typically, what would you

do then?

- 2 A] I'd prepare myself some dinner, get a book to read and I'd 3 sit up and watch TV for two or three hours.
- 4 | Q | Kind of relax from the day?
- A] Yeah, 'cause I wouldn't take a lunch break 'cause I worked steadily the whole time and, uh, it was real, it was a real hot-paced job.
- 8 | Q | Uh-huh?
- 9 A] And I would, uh, actually, you know, it would take me a while to wind down from work.
- 11 | Q] Sure.

- A] And I just enjoyed, I didn't, in the day-time I was busy, 'cause I'd be washing dishes, straighten' up the house, the apart - no, the house, and, uh, straighten' up the house, preparing their dinner for that day, goin' grocery shoppin'.
- Okay. A couple of hours winding down after work when you got home, so typically, what time would you fall asleep?
- 18 A Maybe three or four o'clock in the morning.
- 19 ||Q] Three or four?
- 20 | Al Yeah.
- 21 ||Q] Where would you sleep, typically?
- 22 | A] On the couch.
- 23 Q And let's go through that just for a minute. Where was the 24 couch that you slept on located?
- 25 | A] In the living room.

- 1 Q Okay. Uh, I assume there was a front door to the trailer.
- 2 | Was there a back door to the trailer?
- 3 || A] Uh, yeah.
- 4 [Q] Okay. From your position on the couch in the living room,
- 5 | could you see both front and back doors?
- 6 [A] Sometimes I'd sleep back there in the bed but, I don't
- 7 | know, but two or three times I would sleep on the couch.
- 8 | Q Okay. And assuming that you're sleeping on the couch, can
- 9 | you see the front and back doors?
- 10 [A] I just got in the habit of it. I mean, mostly, I always
- 11 | slept on the couch. And, uh, me and my husband didn't get along
- 12 | real good and I don't know. I just, I slept on the couch a lot.
- 13 | Q | Could you see the front and the back doors from the living
- 14 | room?
- 15 [A] Yeah.
- 16 ||Q| Okay. Uh, now what time would Jason get up to start a
- 17 | regular school day?
- 18 [A] Uh, he would get up I think about six, 6:30 in the morning.
- 19 | Q What time did he have to be at school?
- 20 [A] He had to be at school at eight. He'd always set the alarm
- 21 | clock in his room.
- 22 [Q] Okay. And, and by that time I know you were asleep and did
- 23 | Jason then play a role in helping the younger brothers get up?
- 24 || A] Yeah.

[Q] Get up, get ready for school, brush their teeth; that sort

of thing?

- 2 | A] Yeah.
- 3 | Q | What all would he do?
- 4 A] He would, uh, he would help 'em get ready for school and 5 get dressed.
- 6 Q Okay. So really, if you're falling asleep between 3:00 and
- 7 || 4:00 a.m., Jason is up and getting the boys up around six.
- 8 | We're dealing with two or three hours of time when everybody is
- 9 | asleep; is that right?
- 10 | A] Huh?
- 11 | Q That's probably the worst question I've ever asked. Let me
- 12 | put it this way: Let's change topics a little bit. Explain your
- 13 | trailer, and I've understood that if you've got a front door and
- 14 | a back door. On your windows, is there plastic?
- 15 ||A| There is plastic stapled on the windows because of the cold
- 16 | air that came in from the lake.
- 17 | Q And is that every window on the trailer?
- 18 | A] Yeah.
- 19 | Q And how was it - did you say it was stapled to the
- 20 | windows or the window frames?
- 21 | A] Uh-huh.
- 22 | Q | With what kind of staples?
- 23 | A | What kind of staples? I mean, they had been stapled on
- 24 | there with the staple gun and on the windows.
- 25 [Q] Are we talking about some big construction type staples, or

- 1 | the little paper staples?
- 2 | A] Big staples. Nobody could just tear through it.
- 3 | Q And so was the plastic secure on all of the windows?
- 4 | Al Yeah.
- 5  $\|Q\|$  Does that mean you couldn't get out of a window in your
- 6 | home?
- 7 A] Right.
- 8 ||Q| So the only way for anybody to get in your house was
- 9 | through that front door and that back door; right?
- 10 [A] Right. And he couldn't, he couldn't, and so there was, he
- 11 | was, he was there and nobody was in the back part of the house
- 12 ||or the trailer and it was just, and Jason didn't go nowhere.
- 13 | Q] Okay?
- 14 A I didn't go nowhere. And Matthew or Terry didn't go no-
- 15 || where.
- 16 Q Did Jason have his own bedroom?
- 17 | A | Uh-huh.
- 18 | Q And I take it the two younger boys...
- 19 [A] ... younger boys, he was the oldest so he got his own bed-
- 20 || room.
- 21 | Q Okay. So by the time you got home at night, 11:30, you
- 22 | would be awake for several hours so you would know if somebody
- 23 | was coming and going throughout your house. During the time
- 24 | that you were asleep, three and four and Jason was getting up at
- 25 || six, the only way somebody could get out - if one of the boys

- I wanted to sneak out of the house, they'd have to go by you;
- 2 || right?
- 3 | A] Right.
- 4 ||Q| Because they couldn't get out of a window?
- 5 | A] Right.
- 6 Q All right?
- 7 | A] And they didn't have a habit of sneaking out of the house
- 8 | anyway.
- 9 Q Okay. Next question is, was that something that Jason was
- 10 | known to do?
- 11 [A] No. No. No.
- 12 Q All right. Gail, let's talk now about specifically about
- 13 | May 5th and May 6th of 1993. You remember those days very well, I
- 14 | assume?
- 15 [A] Huh?
- 16 | Q You remember those days very well; is that correct?
- 17 |A| Right.
- 18 [Q] Okay. Because May 6th is when they found the bodies of the
- 19 | little boys; right?
- 20 | A] Right.
- 21 | Q] Okay. On May 5<sup>th</sup>...
- 22 [A] ... I think I found out about it while I was at work the
- 23 | next day.
- 24 | Q] On May 6<sup>th</sup>?
- 25 || A] Yeah. Or it was either at work the next day, or from my

- neighbor, one of my next-door neighbors. I don't remember which one.
- 3 Q Okay. May 5<sup>th</sup> of 1993, did Jason go to school that day?
- 4 | Al Yeah.
- 5 | Q | How do you know that?
- 6 [A] I got his school records.
- 7 | Q Why did you get his school records?
- 8 [A] 'Cause the, the, the, uh, they told me, the police told me
- 9 | if I took his school records, they would let Jason come home.
- 10 | Q | What did the school records reflect?
- 11 | A] Uh, they said, reflected that he showed up, he had an award
- 12 | for being the most punctual student and he also had an award for
- 13 | being must punctual in class, you know, on time for his classes
- 14 | at that time.
- 15 | Q] Uh-huh?
- 16 | A | He had a, uh, uh, and he didn't miss any school.
- 17 | Q Okay. So you, tell us about you getting his school
- 18 | records. Did you go sit down with the principal?
- 19 [A] Yeah, I went and sat down with, I went to the office and I
- 20 | told them I needed my son's school records.
- 21 ||Q] When was that?
- 22 | A] Huh?
- 23 Q When did you do that?
- 24 [A] As soon as the school was open. I was up there like
- 25 | between 7:30 and eight o'clock that morning. And they told me

- 1 | that night, I called there and they told me if I brought his
- 2 | school records, he would come home.
- 3 | Q | And, Gail, to give you some time reference, Jason was
- 4 | arrested June 3<sup>rd</sup>; does that sound right?
- 5 A Right.
- 6 | Q Okay. Would you have gone to the school to get the school
- 7 | records before he was arrested, or after he was arrested?
- 8 | A | After he was arrested.
- 9 | Q | How soon after he was arrested were you at the school to
- 10 || get those school records?
- 11 [A] Excuse me?
- 12 | Q Did you go to the school the next day after his arrest?
- 13 A He was arrested that night.
- 14 || Q] Uh-huh?
- 15 [A] When I come in from work, there were police there.
- 16 | Q | Uh-huh?
- 17 [A] And they, I asked them what's going on?
- 18 || Q] Uh-huh?
- 19 [A] And I, I, and they said go in and ask your husband, 'cause
- 20 | he had come back.
- 21 || Q] Terry?
- 22 | A] Yeah. I had let him come back. I was, I don't know why I
- 23 ||let him come back, uh, one thing...
- 24 | Q] ...oh, let Terry come back. Okay?
- 25 | A] Jason was watching, taking real good care of watching.

- 1 Q His younger brothers?
- 2 | A] Yeah. But nobody knew who murdered those children.
- 3 [Q] Okay?
- 4 A And I was scared that uh, somebody would come in and hurt
- 5 my children, you know?
- 6 | Q] Uh-huh?
- 7 | A] After the murders.
- 8 Q Right. And Gail, I'm going to talk to you about that in
- 9 || just a minute.
- 10 | A] Okay.
- 11 Q The question is: It was after Jason was arrested that you
- 12 | went to the school and got the school records; right?
- 13 | A | Yeah.
- 14 [Q] A day or two, or a month or two after he was arrested?
- 15 | A After he was arrested, the very night, the very morning.
- 16 | Q | The very next morning?
- 17 | A] (Witness nods head affirmatively.)
- 18 |Q| Good. Then, did you get the records for May 5<sup>th</sup> and May 6<sup>th</sup>?
- 19 [A] Uh, I think they gave 'em to me for, I don't know. I think
- 20 | the whole month, even.

MR. HENDRIX: Excuse me just one second.

MR. HENDRIX: My more learned counsel has suggested that you answer "yes" and "no," instead of just "uh-huh," but I take "uh-huh" means yes. Fair enough?

THE WITNESS: Yes.

MR. HENDRIX: I'm sorry about that.

### DIRECT-EXAMINATION, continuing:

- Q] All right. Now let's spend a little bit of time, Gail, after Jason's arrest. Uh, you ended up talking to the police pretty quick; isn't that right, like, maybe the next day?
- [A] I called that night.

- 8 [A] My uncle said he come over and mowed his yard.
- 9 | Q And who is the uncle?
- 10 | A] Uh, his Uncle Hubert said he come over and mowed his yard.
- 11 And he went to Wal-Mart and played some video games there.
- 12 | Q And was he with somebody - and I'm going to take one step
- 13 | back. Back when Uncle Hubert, that's Hubert Bartouch; is that
- 14 | correct?
- 15 | A] Correct.
- 16 | Q | And you, you talked to Uncle Hubert and were you told that
- 17 | Jason had come over that afternoon and mowed his yard?
- 18 [A] Uh-huh.
- 19 | Q And then you mentioned about going to Wal-Mart and playing
- 20 | video games?
- 21 [A] That's what, uh, yeah.
- 22 [Q] And was he with somebody?
- 24 | Q Okay. Then...

- 17 | were doing to him, it caused me a lot of distress, actually, and
- 18 | uh, uh, they would not give me the right medication and, uh,

- 21 | Q | And again, Gail, I, I promise you, I mean this most
- 22 | respectfully, it created psychiatric problems for you and you

- 25 | A] That was a long time ago, though.

- Q] I understand. And, and again, Gail, I swear I'm not, not trying to embarrass you; it's, it's just important. Have I stated that accurately?
  - [A] That was a long time ago.

- Of [And again, for our record, I have to ask this: Is what I have stated accurate?
  - A] Yeah, they, uh, at one time, yes.   - Q] And after his conviction you sort of fell apart, is that right?
  - A] After, there were so many hearings, though, that I had to go to, there were so many hearings I had to go to that, uh, it was so traumatizing for me to see my son like that.

MR. HENDRIX: Your Honor, that's all I have and I

pass the witness. Thank you, Gail.

- 4 | Q] Just a few questions, Ms. Grinell, is all I have. You did,
- 5 | in fact, talk to Mr. Ford and Mr. Wadley regarding your son's
- 6 | case; is that correct?
- 7 [A] Yes.
- 8 Q And you had meetings with them about what you knew and you
- 9 conveyed the information that you had to them, did you not?
- 10 | A] Excuse me?
- 11 Q Did you tell them what you knew about the whereabouts of
- 12 | Jason on the night of the murders; did you tell Paul Ford about
- 13 | that?
- 14 | A] Yeah.
- 15 | Q | Did you tell Paul Ford about your belief that Jason did not
- 16 | have anything to do with this?
- 17 | A] Yeah, I did.
- 18 | Q | And did you tell, did you give them information about him
- 19 | maybe being over at Wal-Mart playing the videos?
- 20 | A | Yeah.
- 21 | Q And did you tell the police that, as well?
- 22 | A] Yeah.
- 23 | Q Okay. And were you aware that the police went to Wal-Mart
- 24 | and looked at video tapes?
- 25 [A] I don't know.

1	Q] Don't know? Okay. Was there anything at the time that you
2	wanted Mr. Wadley or Mr. Ford to do that they didn't do at the
3	time?
4	A] I wasn't allowed in the courtroom and everybody else, and
5	Paul Ford kept telling me there was like all kinds of reasons
6	for them to have, for Jason to get a mistrial and, uh, and, uh,
7	he didn't, they, and I don't understand why he didn't get it.
8	Q] I see. Well, did uh, when they would tell you where Jason
9	was being held, he wasn't always held in a jail there in West
10	Memphis, was he?
11	A] They, he, he kept telling me he was one place. He told me
12	where he was and I kept going there and I couldn't, they kept
13	saying he wasn't there.
14	Q] Okay.
15	MR. HOLT: That's all I have.
16	THE COURT: Mr. Burt, do you have any questions?
17	MR. BURT: No, sir.
18	THE COURT: All right, you may stand down. Call
19	your next witness.
20	MR. BURT: Judge, I'll check in the hall.
21	THE COURT: Sure. I don't think she understands.
22	MR. HENDRIX: And you can stay in the courtroom.
23	THE WITNESS: Okay.
24	(Witness excused.)
25	THE COURT: Do you all have any more expert
