Here is the time schedule on Charles Jason Baldwin.

In the first section the time, June 4, 1993, through July 1, 1993, there was only a minor change. It was changed from 33 hours 17 minutes to 33 Hours and 10 minutes.

The second section of time, July 6, 1993, through December 6, 1993, there was again only a minor change - from 124 Hours 33 minutes to 124 Hours 20 Minutes.

The third section of time, December 17, 1993, through March 19, 1994, there was a total of 478 Hour 5 Minutes. I did not have that broken down on your last copy.

The total hours spent from the beginning changed from 516 Hours to 635 Hours and 35 Minutes. This third section has never been submitted for attorneys fees.
