ON 061493, I INTERVIEWED HUBERT B. BARTOUSH AT HIS RESIDENCE AT 1037 PARK IN WEST MEMPHIS, ARKANSAS. MR. BARTOUSH STATED THAT JASON BALDWIN WAS AT HIS RESIDENCE MOWING HIS YARD ON 050593. HE STATED THAT JASON WAS ALONE AT THAT TIME AND THAT HE GOT TO HIS RESIDENCE AT 4:30 PM AND LEFT AT 6:30 PM. HE STATED THAT ON THIS DATE THAT JASON WAS ALONE AND THAT HE WAS SURE OF THE TIMES BECAUSE OF T.V. PROGRAMS COMING ON.

HE STATED THAT JASON HAD GOTTEN OUT OF SCHOOL ON THAT DATE AND WALKED TO HIS HOME TO MOW THE YARD. HE STATED THAT JASON WAS A FEW DAYS LATE IN MOWING THE YARD AND THAT THE DATE STUCK OUT IN HIS MIND.
