THIS IS DET. BRYN RIDGE OF THE WEST MEMPHIS POLICE DEPARTMENT CURRENTLY IN THE DRUG TASK FORCE OFFICES OF THE WEST MEMPHIS POLICE DEPARTMENT, WITH LT. DET. LT. JAMES SUDBURY AND VICTORIA HUTCHESON, THEY CALL YOU VICKIE IS THAT RIGHT?

VICKIE: YES SIR

RIDGE: ALRIGHT, CURRENTLY INVESTIGATING AN TRIPLE HOMICIDE OF THE THREE BOYS THAT OCCURRED ON 05-05-93. TODAY'S DATE IS ~~5-28-93~~ AND TIME IS 11:07 A. M. UH, VICKIE IF YOU WOULD JUST START WITH UH, FIRST A DESCRIPTION OF YOUR SELF AND WHERE YOU LIVE?

VICKIE: I LIVE AT ROUTE 2 BOX 103, MARION, ARKANSAS AND I'M 5' 10" AND I WEIGH 130 POUNDS, RED HAIR AND GREEN EYES.

RIDGE: AND WHAT IS YOUR BIRTH DATE?

VICKIE: ~~REDACTED~~-63

RIDGE: DO YOU HAVE A VEHICLE OF YOUR OWN?

VICKIE: YES I DO

RIDGE: WHAT KIND?

VICKIE: 77 TOYOTA PICK UP BLUE

RIDGE: ALRIGHT, ON JANUARY OF THIS YEAR WHERE WERE YOU LIVING?

VICKIE: I WAS LIVING AT 1502 EAST BARTON, IN WEST MEMPHIS

RIDGE: OKAY, AND YOU HAVE A SON?

VICKIE: YES I DO

RIDGE: HIS NAME?

VICKIE: ARRON KYLE HUTCHISON

RIDGE: ANY OTHER CHILDREN?

VICKIE: I HAVE ANOTHER SON THAT IS TEN, AND HIS NAME IS DAVID SCOTT HUTCHISON

RIDGE: OKAY, AND THEY LIVE WITH YOU?

VICKIE: AARON DOES LIVE WITH ME. SCOTT WENT WITH HIS FATHER IN FAYETTEVILLE FOR THE SUMMER

RIDGE: UM, NOW PROGRESSING UP UNTIL AROUND THE FIRST PART OF MAY UM, LET'S GO BACK A LITTLE FURTHER TILL THE FIRST PART OF APRIL, WHO ARE AARON'S WHAT I WOULD CALL BEST FRIENDS?

VICKIE: AARON RAN AROUND WITH TWO LITTLE BOYS MICHAEL MOORE AND CHRISTOPHER BYERS AND THOSE WERE HIS ONLY FRIENDS. THE ONLY TWO HE DID RAN WITH.

RIDGE: OKAY, NOW ON THE 5TH YOU PICKED UP AARON FROM SCHOOL THAT DAY?

VICKIE: YES I DID

RIDGE: AND TELL ME WHAT HAPPENED THAT DAY?

VICKIE: I WAS WAITING IN WHERE THE TEACHERS PARK ON THE SIDE OF WEAVER ELEMENTARY, AND WATCHING FOR AARON. IT WAS APPROXIMATELY 15 AFTER 3, AND MICHAEL MOORE CAME TO ONE SIDE OF MY TRUCK AND CHRISTOPHER BYERS TO THE OTHER AND AARON YOU KNOW CLOSE TO THEM AND THEY HAD, AND THEY WERE TELLING ME MS. VICKIE THERE'S A CUB SCOUT THING TONIGHT, AND AARON'S NEEDS TO GO, AND MICHAEL'S FATHER IS THEIR TROOP LEADER AND UM, YOU KNOW, UM MICHAEL WAS REALLY INCESSANT UPON AARON GOING, AND UH, THEY JUST KEPT SAYING THERE'S A CUB SCOUT THING, MS. VICKIE THEY, HE HAS TO GO, HE HAS TO GO, AND I SAID NO THIS IS WEDNESDAY NIGHT, CUB SCOUTS ARE TOMORROW THURSDAY NIGHT AND THEY JUST KEPT ON, FINALLY YOU KNOW, THEY GOT IT THROUGH HE WASN'T GOING TO GO, BECAUSE I JUST THOUGHT THEY WANTED TO GO AND PLAY, AND UM, HE SAID WELL THEN CAN AARON JUST COME TO MY HOUSE, AND YOU CAN PICK HIM UP IN TWO HOURS. WHICH I HAD DONE FREQUENTLY SO HE HAD ASSUMED I WOULD DO IT THEN, AND I JUST SAID NO BECAUSE I HAD SOME ERRAND TO RAN. AARON DID NOT GO.

VICKIE: I WENT HOME

RIDGE: OKAY, AND TOOK AARON HOME WITH YOU?

VICKIE: UM UM, YES I DID

RIDGE: ALRIGHT, DID YOU GO ANYWHERE ELSE AFTER THAT?

VICKIE: I BELIEVE I WENT TO THE GROCERY STORE AND

RIDGE: ABOUT WHAT TIME DID YOU GO TO THE GROCERY STORE?

VICKIE: PROBABLY ABOUT 6:30 OR SO, AND THEN WHILE I WAS IN WEST MEMPHIS I STOPPED AND GOT SOMETHING TO EAT AND ALL THAT KIND OF STUFF

RIDGE: WAS AARON WITH YOU WHEN YOU WENT TO THE GROCERY STORE?

VICKIE: YES HE WAS

RIDGE: HE WAS NEVER ALONE

VICKIE: NEVER

RIDGE: OKAY, ALRIGHT, ABOUT WHAT TIME DID YOU GET HOME?

VICKIE: PROBABLY ABOUT EIGHT OR SO

RIDGE: OKAY, DID YOU GO ANY WHERE ELSE THAT NIGHT?

VICKIE: NO, BECAUSE MY A FRIEND OF MINE HAD, WAS IN THE HOSPITAL HAVING SURGERY AND I TALKED WITH HER ON THE PHONE BEFORE

RIDGE: DID YOU HAVE ANY VISITOR'S ?

VICKIE: I DON'T THINK SO

RIDGE: OKAY, ABOUT WHAT TIME DID YOU GO TO BED?

VICKIE: I USUALLY GO TO BED ABOUT 12:30

RIDGE: WHAT TIME DOES AARON GO TO BED?

VICKIE: AARON GOES ABOUT AT NINE

RIDGE: OKAY, AND THE NEXT MORNING NOW WHAT OCCURS?

VICKIE: THE NEXT MORNING WE HAD GOTTEN UP LATE, MY ALARM DIDN'T GO OFF SO WE WERE RUNNING BEHIND UM, I TOOK AARON TO SCHOOL, AND HE WAS LATE FOR SCHOOL, I DROPPED HIM OFF AND WENT, I DID NOT GO IN THE SCHOOL.

RIDGE: WHAT TIME WAS IT ?

VICKIE: I GUESS, I THINK SCHOOL STARTS AT 8:15 THE BELL RINGS SO, HE WAS ABOUT 10 MINUTES LATE.

VICKIE: AND UM, I WROTE HIM A NOTE, I HAD WROTE HIM A NOTE BECAUSE I HAD A JOB INTERVIEW TO GO TO, AND I NEEDED TO GO SO I DIDN'T GO IN TO TELL THEM ABOUT HIS TARDINESS.

RIDGE: OKAY

VICKIE: UM, I WENT HOME AND I WAS GOING TO GET READY FOR MY INTERVIEW, I TURNED THE TV ON, AND FOUND OUT YOU KNOW THAT THE BOYS WERE MISSING, AND RHONDA WHO WAS IN THE HOSPITAL HAD HEARD, SHE USE TO BABYSIT FOR ME, SO SHE DOES KNOW MICHAEL AND CHRIS AND SHE CALLED TO ASK ME IF THIS WAS THEIR LAST NAMES. AND I TOLD HER YEA, SO I IMMEDIATELY WENT UP TO THE SCHOOL.

RIDGE: OKAY

VICKIE: SO WHEN I GOT TO THE SCHOOL I TALKED TO MRS. KIRKLAND AND MS. WARREN, THE PRINCIPAL, AND THE COUNSELOR, AND UM, THEY TOLD ME YOU KNOW THIS WAS TRUE THAT THEY HAD BEEN MISSING SINCE 6 O'CLOCK, SO THEN I WAS SCARED

RIDGE: ALRIGHT, WHAT TIME WAS THAT CONVERSATION?

VICKIE: UM, ABOUT 9:30 OR 10:00

RIDGE: DID AARON STAY IN SCHOOL THE REST OF THE DAY?

VICKIE: HE STAYED, NO, UM I WENT DOWN TO THE MOORE'S HOUSE TO SEE TODD AND DANA MOORE AND YOU KNOW JUST TO SEE YOU KNOW WHAT WAS GOING ON, AND UM, TODD ASKED ME VICKIE DO YOU THINK MAYBE AARON KNOWS WHERE THEIR AT? AND I SAID I DON'T KNOW I'LL BE GLAD TO GO GET HIM IF YOU THINK IT WILL HELP, IF YOU TALK TO HIM, AND HE SAID I WOULD REALLY APPRECIATE IT, UM, AND I WENT UP AND TALKED TO MS. MOORE AND SHE GOT AARON OUT OF CLASS, I TOOK AARON TO TODD AND DANA'S HOUSE AND UM, TODD ASKED AARON IF HE MIGHT KNOW DID CHRIS OR MICHAEL SAY ANYTHING TO HIM, TO THE EFFECT WHERE THEY MIGHT BE, HE SAID NO, THERE, YOU KNOW YOU CAN TELL WHEN YOUR CHILD IS LYING AND IT WAS LIKE HE KNEW SOMETHING WAS UP, AND UH, HE SAID AFTER WE HAD LEFT THE MOORE'S COMING OUT THEIR DOOR HE TOLD ME MAMA LETS GO TO THE CLUB HOUSE, WE NEED TO GO TO THE CLUB HOUSE,

RIDGE: OKAY, DO YOU KNOW WHERE THE CLUB HOUSE WAS?

VICKIE: YES I DO,

RIDGE: HAVE YOU BEEN THERE BEFORE?

VICKIE: YES... YES I HAVE

RIDGE: AND WHEN WERE YOU THERE BEFORE?

VICKIE: ANY TIME MY CHILD DIDN'T COME HOME ON TIME THAT'S WHERE I WOULD LOOK FOR HIM

RIDGE: OKAY, YOU HAD BEEN THERE ON SEVERAL OCCASIONS? YOU'VE SEEN THE CLUB HOUSE

VICKIE: UH-HUH (YES) I HAVE SEEN IT SEVERAL TIMES

RIDGE: ALRIGHT, AND HE'S BEEN FOUND THERE BY YOU SEVERAL TIMES?

VICKIE: YES

RIDGE: OKAY,

SUDBURY: DO YOU REMEMBER THE LAST TIME YOU WERE THERE THAT YOU SAW IT?

VICKIE: UM, IT WOULD BE RIGHT BEFORE WE MOVED WE MOVED ON THE 19TH OF APRIL

SUDBURY: IT WAS STILL INTACT

VICKIE: IT WAS FINE, OKAY

VICKIE: I REALLY COULDN'T TELL THAT, UNLESS YOU KNOW NOT GETTING UP THERE AND LOOKING AT IT ALL, YEA IT WAS BUT, I WOULD THINK SO, IN ORDER TO HOLD ALL 3 LITTLE 8 YEAR OLDS THAT IT WAS PRETTY STURDY

RIDGE: OKAY, ALRIGHT, SO YOU WENT TO THE CLUB HOUSE THAT DAY?

VICKIE: NO, I, ATTEMPTED TO GO TO THE CLUB HOUSE, BY THIS TIME IT HAD GOTTEN I DID STAY AND VISIT WITH TODD AND DIANE

RIDGE: ABOUT TIME WAS IT YOU WENT TO TRY AND GO TO THE CLUB HOUSE?

VICKIE: IN MIDDLE AFTERNOON

RIDGE: OKAY, AND WHAT DID YOU FIND WHEN YOU CAME TO THE AREA?

VICKIE: UM, WEST MEMPHIS POLICE HAD ALL OF THE AREA ROPED OFF

RIDGE: OKAY

VICKIE: I WENT TO THE DEAD END IT WAS YOU KNOW

RIDGE: DEAD END?

VICKIE: IT WAS COPS

RIDGE: WHAT ARE YOU TALKING ABOUT DEAD END?

VICKIE: THE DEAD END ON MCAULEY

RIDGE: ON MCAULEY BY

VICKIE: BY THE APARTMENTS

RIDGE: OKAY, ALRIGHT, SO WHAT HAPPENED NEXT?

WHICH WAS A ATTENTION EPISODE DISORDER AND ON MEDICATION, SO THEY WERE LIKE YOU KNOW LIKE TOOK THEIR MEDICINE TOGETHER AND DID EVERYTHING TOGETHER AND YOU KNOW I'M SURE HE'S JUST HEART BROKEN, HE WON'T LEARN ANYTHING

RIDGE: ALRIGHT, AND YOU WENT TO ONE OF THE FUNERALS, WHICH FUNERAL DID YOU GO TO?

VICKIE: I WENT TO BOTH FUNERALS, CHRIS AND MIKE'S

RIDGE: ALRIGHT, AT ONE OF THESE FUNERALS YOU WERE APPROACH BY?

VICKIE: A COMMERCIAL APPEAL REPORTER

RIDGE: OKAY, UM, AT THIS POINT IN YOUR MIND WHAT DID YOU DECIDE THAT YOU WERE GOING TO DO?

VICKIE: I DECIDED THAT, THAT IT WAS CONSTANTLY ON TV, OR CONSTANTLY IN THE PAPER, CONSTANTLY SOMEBODY WAS SAYING SOMETHING ABOUT IT, I DECIDED THAT MY SON WOULD BE BETTER OFF AWAY UNTIL IT COOLS DOWN, AND I SENT HIM TO MY SISTERS HOUSE IN FORT SMITH, ARKANSAS.

VICKIE: NO HE DIDN'T.

RIDGE: OKAY, ALRIGHT, SO THE RELATIONSHIP CONTINUED.

VICKIE: YES

RIDGE: ALRIGHT. AND WHAT HAPPENED?
