KENNETH- LAKESHORE ON SUMMER. I'M NOT SURE WHAT THE ADDRESS IS, BUT IT'S SLOT 47.

RIDGE- OKAY. IT'S UH, WOULD IT, 3070 SUMBER #47.

KENNETH- YES SIR.

RIDGE- THAT'S LEHEE TRAILER PARK? OKAY, AND YOUR MOTHER IS ALSO HERE WITH ME. UH, SHIRLEY GREENWOOD, YOUR SISTER, ALICE DAWSON, AND DET. BILL DURHAM. OKAY WE'RE CURRENTLY INVESTIGATING THE OFFENSE OF THE TRIPLE HOMICIDE THAT OCCURRED ON 5/5/93, MAY THE 5TH OF 93. CAN I GET YOU TO REMEMBER BACK TO THAT DATE? UH, DO YOU REMEMBER WHAT YOU WERE DOING THAT DAY?
