Pursuant to this Court's Letter Order issued on November 21, 2007, petitioner Damien Echols hereby reports the following concerning the status of state court proceedings relating to this matter:

On April 14, 2008, undersigned counsel, on behalf of petitioner Echols, filed in the Craighead County Circuit Court of Arkansas a motion for a new trial based on new scientific evidence pursuant to Ark. Code § 16-112-201, et seq.

On April 15, 2008, undersigned counsel, together with counsel for Jason Baldwin and Jesse Misskelley (the other state defendants seeking state court relief under § 16-112-201, et seq.), and counsel for the state of Arkansas appeared at a status hearing before Craighead County Judge David Burnett.

At the April 15<sup>th</sup> hearing, Judge Burnett set a briefing and hearing schedule in connection with the pending state proceedings. Specifically, Judge Burnett ordered that:

- (1) the state of Arkansas was to respond to petitioner Echols's new trial motion by May 30, 2008;
- (2) petitioners Baldwin and Misskelley were to file their opening pleadings based on new scientific evidence (and on other grounds not available to petitioner Echols) by May 30, 2008;
- (3) the state was to respond to the Baldwin and Misskelley pleadings by July 15, 2008;
- (4) a status hearing will convene on August 20, 2008 to determine the scope of the hearing on petitioners' motions and pleadings; and

(5) hearing on petitioners' motions and pleadings will commence on September 8, 2008, and, if needed, extend to and including October 3, 2008.

In accordance with Judge Burnett's April 15, 2008 order:

- (1) the state filed its response to petitioner Echols's motion for a new trial on May 30, 2008;
- (2) counsel for petitioner Baldwin filed his pleadings supporting his requests for post-conviction relief on or before May 30, 2008; and
- (3) counsel for petitioner Misskelley sought and received a 7 day extension of time, to and including June 6, 2008, to file his pleadings supporting his requests for post-conviction relief.

Petitioner Echols will inform this Court of further developments in the state court proceedings in his July, 2008 status report to this Court.
