

AFFIDAVIT OF PEGGY VANHOOZER NICHOLSON

Before the undersigned Notary Public, duly qualified and acting in and for said county and state, appeared Peggy Vanhoozer Nicholson, to me well known to be the affiant herein, who stated the following under oath:

- “1. My name is Peggy Nicholson. Prior to my marriage to my husband Timothy Nicholson, I was known as Peggy Vanhoozer. My date of birth is [REDACTED] 1952.
2. I was one of the jurors in the trial of Damien Echols and Jason Baldwin.
3. Before serving as a jury on the case, I was aware that there had been an earlier trial in Corning. I knew the person who had been tried was Jessie Misskelley. I knew that Misskelley had been found guilty. I believe I also knew that Misskelley had confessed to the crime.
4. At the time I was picked to sit on the jury I worked as a nurse at St. Bernard’s Hospital in Jonesboro, Arkansas.
5. I did not know any of the jurors prior to being picked to serve on the jury.
6. When I did get picked, I found that all of the jurors got along well.
7. I kept my notes of the trial. I tried to take good notes. I remember taking notes during deliberations. I noted down the information that someone, I

- think it was the housebuilder named Kent, put down on some large sheets of paper in the jury room. I remember writing down what was written down on those big sheets of paper just the way he wrote them down.
8. When we discussed the case, we discussed each of the two defendants. We placed items on the pro or con side of the large sheets that were used in the jury room. We did the same for some of the witnesses.
 9. The notes that I have, as far as I know, accurately reflect what was said in the court, and during the deliberations, including what was written on the large sheets of paper that were in the jury room. An exact copy of my notes has been stapled to this affidavit, and I have signed and dated those notes. *
 10. I have spoken with Investigator Tom Quinn. I provided him with a copy of my notes. Those notes have not been modified or tampered with since I made them. I believe they reflect exactly what I noted either during the trial, or during the jury deliberations, including the notes that were made on the large sheets of paper inside the jury room.
 11. I have been asked to specifically review the notes of the pro and con information about Jason Baldwin. The word that is crossed out is the word "satanic". The word that follows the crossed out word "satanic" is the word "follower".
 12. On the line above the words I have just identified I wrote "J. Misk. State". That was my shorthand for "Jessie Misskelley Statement".
- * 9.1 I reviewed, initialed and numbered 40 pages of copies of my notes (see attached), excluding 2 pages of Damon Echols poetry that I copied from his medical records.

13. In my view, based on my own background and beliefs, Damien Echols seemed to me to be Satan walking alive. I felt differently about Jason Baldwin. He seemed to be different than Damien. Other jurors and I felt it would have been better for Jason if he had not been tried with Damien.
14. I have been asked if I remember talking to other jurors about one another's notes, and talking about the case during the course of the trial. We did talk about the case during the trial, because we were trying to be careful.
15. As far as I recall we either heard testimony about, or discussed during jury deliberations, all of the subjects and matters that are reflected in my notes.
16. I have read the foregoing statements and state that they are true and accurate to the best of my knowledge and belief."


