MOTION FOR JOINDER OF OFFENSES

Comes Brent Davis, Prosecuting Attorney within and for the Second Judicial District of the State of Arkansas, of which Crittenden County is a part, by and through John N. Fogleman, Deputy Prosecuting Attorney for Crittenden County, Arkansas, and for his Motion for Joinder of Offenses, states:

(1) The defendants, Jesse Lloyd Misskelley, Jr., Charles Jason Baldwin and Damien Echols, a/k/a Michael Wayne Echols, have been arrested and charged with three counts of Capital Murder, which all occurred at the same location on the same date and at approximately the same time.

(2) Pursuant to Rule 21.1 of the Arkansas Rules of Criminal Procedure, the State moves the Court to join each of the three separate Capital Murders for trial in one trial because the offenses are based on the same conduct or on a series of acts connected together or constituting parts of a single scheme or plan.
